**TRYOUT INFORMATION 2017-2018  
(Rules, Terms & Conditions)**

Welcome to The Stingray Allstars! We are delighted that you have chosen to become a part of one of the most prestigious allstar programs in the country. Our mission at The Stingray Allstars is to enrich the lives of the children and their families through the sport of competitive cheerleading. Our goal each day is to teach our athletes the value of commitment, hard work, integrity, leadership, self-confidence, positive attitudes and a love for the sport. Each and every family is important to us and our program.

**ONLINE REGISTRATION (SEE INSTRUCTIONS ON THE WEBSITE):** Once you have completed your online registration, turn in your **completed Tryout Form** to your front office.

**TRADITIONAL REGISTRATION (PRINTED FORMS FROM THE WEBSITE):** You are required to turn in the Financial Commitment/Credit Card Info page, Tryout Form, Participant Information Form, Participant Agreement Form and your tryout fee. **NO INCOMPLETE PACKETS WILL BE ACCEPTED.**

**\*\*Be sure to have your cheerleader's photo taken when you turn in your paperwork to your gym's front office. \*\***

**\*\*Please provide a photocopy of your child's birth certificate with completed tryout packet. \*\***

Tryout fee is **\$50.00** if you turn in your completed packet by **Thursday April 20<sup>th</sup>**. Any tryout packet turned in on **Friday April 21<sup>st</sup>** or after will be charged a **\$75.00** tryout fee. Private Tryouts are \$200.00 and must be scheduled through your front office. **THIS IS A FIRM DATE, NO EXCEPTIONS.**

**TUITION:**

May 2017 through January 2018 monthly tuition payments are \$285.00.  
February 2018 through April 2018 monthly tuition payments are \$180.00.  
All payments are made to Stingray Cheer Co., Stingray Sport Center or Stingray Brands (payable to your specific gym).

**MONTHLY TUITION INCLUDES:**

All team practices and a reserved spot in a one-hour weekly tumble class.  
Allstar Camp (There are additional fees for Level 5 Camp)

**MONTHLY TUITION DOES NOT INCLUDE:**

**APPROXIMATE COSTS:** (based off previous years, these prices are subject to change):

Full Uniform \$375.00, Used Uniform \$187.50, Warm-ups \$165.00, Shoes \$85.00-100.00, Bows \$10.00-20.00, Backpacks \$85.00-\$95.00, Practice Wear/Shirts/Jerseys/Sweatshirts \$30.00-\$50.00, Summit Fee \$100.00-\$395.00, Level 5 Stunt Camp \$175.00. Travel costs will vary greatly.

**Again, these are estimates and are subject to change.**

**BILLING:** Your monthly fees will be billed to your Stingray account on the 1<sup>st</sup> of each month. Fees are due on or before the 7<sup>th</sup> of each month. On the 8<sup>th</sup> of each month any outstanding balance will be charged to the credit card that you provided. Stingray Cheer Co., Stingray Sport Center and Stingray Brands accept cash, checks, money orders and debit/credit cards. You may also pay online at [www.stingrayallstars.com](http://www.stingrayallstars.com). Follow the prompts to your gym location. If you have any questions about your account, feel free to contact the office.

**All accounts must be paid in full in order to tryout for the upcoming season and you must keep your 1 account current to remain active on your team.**

**There will be no refunds made to anyone who is asked to leave the program or that quits a team.**

## PROGRAM RULES/CODES OF CONDUCT:

- If you have any questions or concerns that need immediate attention, please use the following chain of command:  
1. Team Rep 2. Head Coach 3. Allstar Director 4. Owner/President
- Good sportsmanship, polite manners and a good disposition are mandatory at all practices and competitions.
- If you are an alternate on a team your tuition will be the same, you are also expected to attend all team practices.
- Crossover Policy; if you are asked to be a crossover athlete you will be responsible for the crossover fees in addition to your regular tuition.
- Athletes will be required to arrive at scheduled practices 15 minutes prior to start time. Coaches will use this time to maintain and better your team skills.
- It is your responsibility to wear the appropriate practice wear to every practice.
- Personal items such as cell phones, school bags, or gym bags must be taken into the gym and stored in the cubbies adjacent to your practice floor. NO items are to be left in the gym hallways and cell phones must be turned off when practice starts.
- You must arrive at all practices, competitions or any scheduled event on time. Punctuality is a MUST.
- During practice your opinion does not count. All squad and routine decisions are left to the discretion of the coaches.
- Please feel free to talk to your coach about anything; remember to do it at the appropriate time. For example, approaching a coach in the middle of a practice would not be an appropriate time.
- Athletes need to be able to physically and mentally perform all aspects of competitive cheerleading.
- NO GOSSIP about any other teams (allstar or school). NO GOSSIP about a child on your team or another team. NO GOSSIP about coaches and staff. It is much better to address a problem than to listen to idle gossip.
- No profanity or abusive language.
- Please keep in mind the gym is not a babysitting service. We want our Allstars to use the gym as often as possible, but no child should be dropped off at the gym unsupervised.
- Never post any negative comments on social media.
- Practices may be changed or added at any time during the season.
- Anyone threatening to quit or to pull their child from a team will be dismissed from the program immediately.
- Only cheerleaders and coaches are allowed in the gym, seriously.
- No one is allowed to yell onto the floor or try to make contact through the parent viewing area window during practices or tumble classes. This is extremely distracting to all involved.
- The coaches reserve the right to close practices at ANY time for ANY reason. In this event, the team rep will remain at practices.
- It is the parent's responsibility to know what is going on with your squad. Check your emails, GroupMe/Remind 101 and the website regularly. Follow @Cvillerays on Twitter and Facebook at The Stingrays Cartersville.
- Withholding a child from a practice or a competition should never be used as a form of punishment.
- Athletes should be able to handle school work and allstar practices, homework is not an acceptable excuse for missing practice.
- Parents, relatives, friends and cheerleaders are never allowed to speak with competition officials for any reason. Ever.
- Parents are never allowed to represent The Stingray Allstars under any circumstances concerning accommodations, competitions or any other situation. Ever.
- There will be no arguing or questioning of the coaching staff's decisions at competitions.
- If a problem arises between you and a teammate or another parent, the problem will be addressed with all parties involved at a meeting with your coach and the Allstar director.
- Anonymous emails/letters/texts/tweets, etc. will be ignored.
- The Stingray Allstars maintain the right to refuse services at any time.
- The Allstar Director may change, add or subtract any rule at any time.

## CLASS POLICIES:

- Every cheerleader is entitled to **1** tumble class per week.
- Up to 2 extra drop-ins per week, when available.
- Accounts must be **current** to do drop-ins, privates, additional tumble, stunt or stretch classes.
- If your account becomes delinquent, any private lessons or extra classes will be dropped until your account is in good standing.
- Trust the Process.

## TRAVEL:

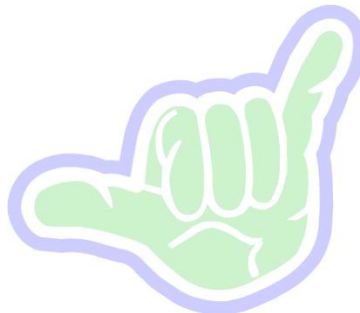
- **DUE TO CONTRACT AND "STAY TO PLAY" OBLIGATIONS ALL ATHLETES ARE REQUIRED TO STAY AT TEAM HOTELS.**
- There must be a parent in every room, no exceptions.
- Each cheerleader must have a chaperone at every competition. It is not your coach, Team Rep or Stingray staff's responsibility to be your child's chaperone.
- It is your responsibility to pay the hotel directly for your room.
- Proper traveling attire will be discussed with each team prior to an out of town competition.

## APPAREL:

- All Stingray logos and brands are protected. #nopirating
- All spirit wear items are to be purchased through Full Out Sports.
- If a sponsor wants to buy an item for entire team that order must go through Full Out Sports as well. Sponsors simply donate the money; the coaches will decide on what is purchased.
- All spirit items must be approved by Full Out Sports; coaches have sole authority on apparel designs (this includes sponsored items also).
- Bows, t-shirts, bags, blankets, etc. with an identifiable icon (i.e. orange slice, clover, peppermint candy) not purchased through Full Out Sports are not permitted. Teams will not be allowed to wear or use as a group.
- Anyone that attempts to sell or give away items with Stingray logos or likenesses will be in violation of our policy.
- Money cannot be asked of parents to buy spirit items, goody bag items or any other non-mandatory items. Team Reps may collect money for coach gifts, but this is strictly voluntary.

As parent or legal guardian of \_\_\_\_\_, a minor ("Minor"), and in consideration for Minor's participation in the cheerleading, dance and other activities and services, including, without limitation, travel to and from such activities, competitions, conferences, meetings, and other events that may require travel (collectively, the "Activities"), conducted and provided by STINGRAY CHEER COMPANY, INC., a Georgia corporation; STINGRAY SPORT CENTER, LLC, a Georgia limited liability company; STINGRAY BRANDS, LLC, a Georgia limited liability company, and their respective affiliated entities, owners, agents, officers, employees, representatives, and all other persons or entities acting in any capacity on their behalf (collectively, "SA"), I AGREE AS FOLLOWS:

**I. Liability Release.** ON BEHALF OF MYSELF AND MY HEIRS, ASSIGNS, EXECUTORS, AND ADMINISTRATORS, I RELEASE AND FOREVER DISCHARGE SA FROM ALL CLAIMS, JUDGEMENTS, LOSSES, LIABILITIES, DAMAGES, COSTS, AND EXPENSES (COLLECTIVELY, THE "CLAIMS") OF ANY NATURE ARISING OUT OF OR IN ANYWAY RELATED TO THE MINOR'S PARTICIPATION IN THE ACTIVITIES WHETHER OCCURRING ON THE PREMISES OF ANY SA LOCATION OR ANY OTHER LOCATION; I FURTHER AGREE TO DEFEND, INDEMNIFY, AND HOLD HARMLESS SA FROM AND AGAINST ANY AND ALL SUCH CLAIMS, INCLUDING, WITHOUT LIMITATION, ATTORNEYS' AND OTHER PROFESSIONALS' FEES AND COSTS. I understand that this release and discharge of Claims includes, without limitation, any Claims based on the negligence, action, or inaction of SA and covers personal and bodily injury (including death) and property damage, whether suffered by Minor before, during, or after participation in any Activities, and includes all Claims arising from the publication of use of any photograph, videotape, or narrative in any media. I acknowledge that SA makes no representations or warranties, either express or implied, regarding the condition or suitability of SA's or any other locations or equipment for the Activities. The laws of the State of Georgia shall govern this release and indemnity agreement.

**II. Medical Release.** I acknowledge and agree that Minor's participation in the Activities subjects Minor to the possibility of physical illness or serious injury (including death). I further acknowledge and agree that Minor is assuming the risk of such physical illness or serious injury (including death) by participating in the Activities. In the event of such physical illness or injury, I authorize SA to obtain necessary medical treatment for Minor and I release, hold harmless, and forever discharge SA from any Claims arising from or related to any physical illness or serious injury (including death) and to the exercise of this authority. I further acknowledge and agree that I will be responsible for any and all medical and related costs and expenses incurred by and on behalf of Minor for any such physical illness or injury.

**III. Appearance Agreement.** I understand that SA may from time to time produce promotional and other audio or visual materials and media relating to the Activities (the "Promotional Material"). I understand that, as a participant in or spectator of such Activities, Minor may be included in video recordings, audio recordings, photographs, and images taken during Activities for use in Promotional Material. THEREFORE, I HEREBY ASSIGN, TRANSFER, AND GRANT TO SA, WITHOUT RESERVATION OR LIMITATION, THE ROYALTY-FREE, EXCLUSIVE RIGHT TO USE SUCH VIDEO RECORDINGS, AUDIO RECORDINGS, PHOTOGRAPHS, AND IMAGES OF MINOR, AS WELL AS MINOR'S NAME, LIKENESS, PERSONAL AND DEMOGRAPHIC INFORMATION, VOICE AND APPEARANCE AS PART OF ANY PROMOTIONAL MATERIAL. IN GRANTING THIS LICENSE, I HEREBY WAIVE ANY RIGHT TO INSPECT OR APPROVE ANY SUCH PROMOTIONAL MATERIAL PRIOR TO PUBLICATION. Confidentiality.** I acknowledge and agree that SA develops and creates unique and valuable proprietary dance routines, cheerleading routines, training techniques, and other intellectual property that are unique and valuable to SA and that may be used to prepare for and participate in competitive events (collectively, the "Intellectual Property"); I further acknowledge and agree that maintaining the confidential and proprietary nature of the Intellectual Property is of the utmost importance to SA and its competitive success. I understand that I may video-record, audio-record, photograph, or take other images of the Intellectual Property solely for my, Minor's, or Minor's immediate family's personal, non-commercial use; PROVIDED ALWAYS, HOWEVER, THAT MINOR AND I SHALL NOT POST OR UPLOAD ANY SUCH RECORDINGS OR IMAGES TO ANY WEBSITE OR SOCIAL MEDIA PLATFORM (INCLUDING, BUT NOT LIMITED TO, FACEBOOK, TWITTER, INSTAGRAM, AND YOUTUBE), OR IN ANY PUBLIC FORUM WITHOUT THE PRIOR WRITTEN CONSENT OF SA.

**V. Breach.** I ACKNOWLEDGE AND AGREE THAT ANY BREACH OR THREATENED BREACH OF SECTION IV OF THIS AGREEMENT WILL CAUSE SA IRREPARABLE INJURY FOR WHICH NO ADEQUATE REMEDY AT LAW IS AVAILABLE AND I CONSENT TO THE ISSUANCE OF AN INJUNCTION PROHIBITING ANY CONDUCT VIOLATING THE TERMS OF SECTION IV. I ACKNOWLEDGE THAT ANY VIOLATION OF THIS AGREEMENT BY MINOR OR BY ME MAY RESULT IN MINOR BEING SUSPENDED FROM OR PERMANENTLY EXPELLED FROM PARTICIPATION IN SOME OR ALL ACTIVITIES AND MY SUSPENSION FROM ATTENDING AND SPECTATING SOME OR ALL ACTIVITIES.
